Mr. Schreiber noted that over the last 30 days, the CCMUA received 4 external odor complaints (3/21, 3/29, 4/1 and 4/12). An investigation was performed for each event and the good news is there does not appear to be a process/systemic problem causing the odors:

- 3/21 Removal of waste and power washing of a vehicle; power washing (issue was addressed with CCMUA staff)
- 3/29 Dryer facility door left partially open (issue was addressed with Synagro staff)
- 4/1 Rupture panels on top of silos failed (once the failure was notice, the system was shut down to minimize odors and repairs be made)
- 4/12 Collectors in primary tanks failed after a high (wet weather) event (extra primary tanks had been in service due to high flows and one of the tank collectors failed, resulting in odors.)

Mr. Schreiber shared a screenshot of the odor monitoring software report for the April 12<sup>th</sup> odor event.

## E) Operations & Maintenance:

1) Del. No. 1 WPCF- Operations Report- January 2024
Mr. Gipson updated the Board on the Main Plant's operation. He noted that from April 2<sup>nd</sup> through the 6<sup>th</sup>, the plant received record flows of 132MGD which exceeded the previous high by almost 10M gallons. The plant received over 100MGD for a 24-hour period which is significant and over a five day period the plant treated over 100MGD every day as compared to 40-45MGD on a typical dry weather day. Since the plant's expansion, the plant has performed well during these intense wet weather events. Kudos to the operations and maintenance staff.

# **NEW BUSINESS/PUBLIC HEARINGS (Resolutions #64-66):**

Commissioner Bresch noted that per regulation, the CCMUA is required to have a Public Hearing prior to the CCMUA Board adopting specific resolutions. On tonight's meeting agenda, there will be three separate public hearings in support of three separate and distinct matters/resolutions. The same format for each hearing will be followed. First, Mr. Schreiber will read the resolution into the record, then the public hearing will be open for the public to comment. After the public has commented, the public portion of hearing will be closed, and a request will be made for a motion from the Board and a roll call vote will be taken.

Vice-Chairman Bresch noted that the first public hearing is regarding the CCMUA's Sewer Use Ordinance. Mr. Schreiber read Resolution #R-24:4-64 for the record. A motion was made by Commissioner Cuffee and seconded by Commissioner Johnson to adopt Resolution #R-24:4-64, authorizing non-substantial modifications under N.J.A.C. 7:14A-19.9 to Camden County Municipal Utilities Authority Sewer Use Ordinance. There being no question on the motion, the Commissioners responded to their names as follows:

Vice-Chairman Bresch noted that the second public hearing is regarding the CCMUA's Connection Fee. Mr. Schreiber read Resolution #R-24:4-65 for the record. A motion was made by Commissioner Cuffee and seconded by Commissioner Stokes to adopt Resolution #R-24:4-65, authorizing the revision of connection fee. There being no question on the motion, the Commissioners responded to their names as follows:

Resolution #R-24:4-65 was adopted.

Vice-Chairman Bresch noted that the final Public Hearing for tonight is regarding the CCMUA's Sewer Use Charges. Mr. Schreiber read Resolution #R-24:4-66 for the record. John Poliero, Haddonfield resident, asked if there has ever been any consideration about putting this CCMUA into the Camden County government as a tax instead of a fee. Mr. Schreiber explained that Municipal Utilities Authorities, like the CCMUA, are governed by NJ law and under the law, the CCMUA is obligated to charge a standalone user rate to support its operations and capital needs. Mr. Watson, the CCMUA's Solicitor, also addressed Mr. Poliero, adding that the CCMUA's enabling legislation carves out all the various obligations, authority, rights, etc. that the CCMUA has. One of the provisions in the legislation directly addresses the CCMUA's ability to collect connection fees and sewer user fees. The CCMUA is not permitted to pick and choose which parts of the legislation applies so, as long as the CCMUA is governed by the Statute/legislation, it would not be able to move forward as suggested. Mr. Poliero thanked both Mr. Schreiber and Mr. Watson for their responses, further adding that the CCMUA has done a great job in treating wastewater properly and protecting the local waterways, and he was asking the question to see if there was a way to write off the payment in one's taxes. Mr. Schreiber suggested that, if Mr. Poliero wanted more information on the CCMUA and its history, he should reach out to him directly by email. Mr. Schreiber added one last comment for the record: The CCMUA has not raised the user rate since 2015 and, had it done so (by the inflation rate per year), the current rate would be \$462/year, versus \$372. A motion was made by Commissioner Cuffee and seconded by Commissioner Stokes to adopt Resolution #R-24:4-66, authorizing a revision of sewer use charge. There being no further question or comment on the motion, the Commissioners responded to their names as follows:

Mr. Schreiber reminded the Board that funding for this project was obtained by the Camden County Improvement Authority (via a grant). There being no further question or comment on the motion, the Commissioners responded to their names as follows:

A motion was made by Commissioner Stokes and seconded by Commissioner Johnson to adopt Resolution #R-24:4-79, second resolution amending certain provisions of the "Resolution authorizing the issuance of not exceeding \$44,975,000 County Agreement Subordinate Bonds of the Camden County MUA and providing for their sale to the New Jersey Environmental Infrastructure Bank (f/k/a The New Jersey Environmental Infrastructure Trust) and the State of New Jersey and Authorizing the Execution and Delivery of Certain Agreements in Connection Therewith" adopted April 19, 2021 and approving the form of a second amended and restated subordinate bond resolution. Mr. Schreiber explained that this resolution is to allow an additional \$3M in funding to cover the cleaning of Camden City Sewer system. Mr. Schreiber further explained that this project will be completed before the scheduled bar screen improvements at the head of the main plant to prevent damage to the CCMUA's newly upgraded processing system. This cleaning project is funded by the State of NJ at 80% principal forgiveness. The remaining 20% not covered by the State's principal forgiveness will be reimbursed by the City of Camden to the CCMUA. There being no further question or comment on the motion, the Commissioners responded to their names as follows:

Mr. Schreiber noted that there are no guaranteed minimums for any bidder (it is as needed). There being no question on the motion, the Commissioners responded to their names as follows:

24:4-82, authorizing a non-fair and open contract to Atlas Copco Compressors, LLC for maintenance of Atlas Copco Instrument Air Compressors/Dryers. There being no question on the motion, all Commissioners responded "Aye" in favor, none opposed.

Resolution #R-24:4-82 was tabled.

A motion was made by Commissioner Swartz and seconded by Commissioner Sytnik to adopt Resolution #R-24:4-83, ratifying approval of expense vouchers as approved by the Executive Director under Authorization granted by CCMUA Resolution #R-97:3-60 dated March 18, 1997. There being no question on the motion, the Commissioners responded to their names as follows:
