AUTHORIZING THE EXECUTION OF AN AGREEMENT BETWEEN THE CCMUA AND
ATLAS COPCO FOR THE EMERGENCY PROCUREMENT OF VSA COMPRESSOR-
RELATED ITEMS PURSUANT TO N.J.S.A 40A:11-6

R-24:11-195

Whereas, oxygen generation is a critical component of the activated sludge process and has direct impact on the level of wastewater treatment achieved by the Camden County Municipal Utilities Authority's ("CCMUA") wastewater treatment facility; and

Whereas, half of the air compressor system for the VSA facility is out of service requiring parts and repairs to the VSA control system; and

Whereas, because the generation of oxygen is vital to the CCMUA plant's operation, its continuous, uninterrupted operation must be ensured; and

Whereas, in addition, the absence of a continuous, uninterrupted supply of oxygen would impede the CCMUA's ability to meet NJDEP permit requirements; and

Whereas, Atlas Copco has provided the CCMUA with two quotes; one in the amount of \$6,405.68 to replace all main motor starter/contactors on compressors Serial #'s API786346 and API785414 and the other in the amount of \$4,662.28 to replace various air dryer compressors parts Serial #'s API088787 and API088788; and

Whereas, any disruption in the production of pure oxygen would significantly impair the CCMUA plant's operations which, in turn, could have a grave impact on human health, safety and welfare, as well as the welfare of the community and environment; and

Whereas, the need to procure a parts and service for the compressed air system and under emergent circumstances could not have been reasonably foreseen; and

Whereas, the Authority and Atlas Copco have agreed to the provision of parts and service to repair the instrument compressed air system for the VSA facility.



Now, Therefore Be it Resolved by the Authority Board of Commissioners that the Executive Director and/or his designee are hereby authorized to take all necessary steps to negotiate and execute, after consultation with the Authority's General Counsel and Solicitor, an agreement to procure a temporary compressed air system and repair of the existing out-of-service system from Atlas Copco utilizing an emergency procurement as allowed under New Jersey Local Public Contract Law N.J.S.A 40A:11-6.



WHEREAS, the software is a unique, specialized and proprietary product under N.J.S.A. 40A:11-2(39) and N.J.S.A. 40A:11-5(1)(dd), and is a service that is specifically tailored to entities such as the CCMUA; and

WHEREAS, the CCMUA has relied on and utilized the New World Purchasing and Financial Software for approximately thirty-three (33) years, and New World's proprietary software is a specialized product and is a vital part of the CCMUA's day-to-day operations; and

WHEREAS, Tyler Technologies Inc. has issued an invoice (#045-488771), dated November 15, 2024 to the CCMUA in the amount of \$39,836.77 for Support and Update Licensing for the Purchasing, Financial Management Base Suite, Project Grant Accounting and Fixed Assets software packages; and

WHEREAS, sufficient monies are available and have been certified as being encumbered in accordance with N.J.A.C. 5:30-5.4 per the attached Certification of Available Funds. The line item appropriation of the official budget adopted pursuant to the Local Budget Law which the expenditure will be charged in accordance with the comptroller function is noted on the attached Certification of Available Funds.
